### Bio

### Representative Cases

#### Trial Verdicts

Derek Chen and Stew Estes obtained a defense verdict on behalf of the South Correctional Entity (SCORE). The plaintiff claimed corrections officers assaulted her during a pat-down search, causing her various physical and emotional injuries. The jury returned a defense verdict in less than an hour.

#### Summary Judgment Dismissals

Derek Chen and Stew Estes obtained a full summary judgment dismissal on behalf of the Seattle School District and two individual employees who were named defendants. The defendants were accused of violating the plaintiffs' First Amendment rights, as well as multiple torts related to their removal from District property.

Derek Chen and Jayne Freeman obtained a full summary judgment dismissal on behalf of the Town of Steilacoom. The plaintiff was a former employee who claimed he was discriminated and retaliated against based on his union activities and an alleged disability.
